
Swedish Higher Education in Figures

- Funding : 1,8 % of GDP to postsecondary education (OECD average: 1,3 %.)
- Proportion of population with postsecondary qualifications: 33 % (OECD average: 30 %).
- About 363,000 students enrolled in 1st and 2nd cycle programmes.
- Median age for university entrants: 22,1 (OECD average 20.5).
- The percentage of women in HE is about 60 %.
 2/3 of all qualifications are awarded to women.






The institutions



- Sweden's first university was established Uppsala in 1477.
- 14 state universities and 20 state university colleges. 17 non-state institutions.
- Universities are research-oriented, whereas university colleges focus on undergraduate programs.
- Qualifications from all recognised HEIs have equal value.

The students: What do they study?






Tuition fees, student grants and loans

- No tuition fees for Swedish and EU/EES nationals.
- Students in Sweden can obtain state support consisting of combination of study grants and loans.
- Per academic year (9 months):
 €2,914+€6,381= €9,295 (2012)
- Student aid is payable for a maximum of 6 academic years.
- The debt is expected to be repaid in 25 years, or before the individual reaches the age of 60.





Incoming and outgoing students



- Proportion of incoming students: from 4% to almost 11 % during the past decade (OECD average: 7 %.)
- Tuition fees introduced for non-EU/EES students 2011.
- Fall semester 2011: incoming students (freemovers) from non-EU/EES decreased with 79 %.
- Fall semester 2012: incoming students (freemovers) from non-EU/EES increased with 7 %.




Quality Assurance System

New QAS 2011-2014


- Achieved learning outcomes in relation to intended learning outcomes as stipulated in the legislation.
