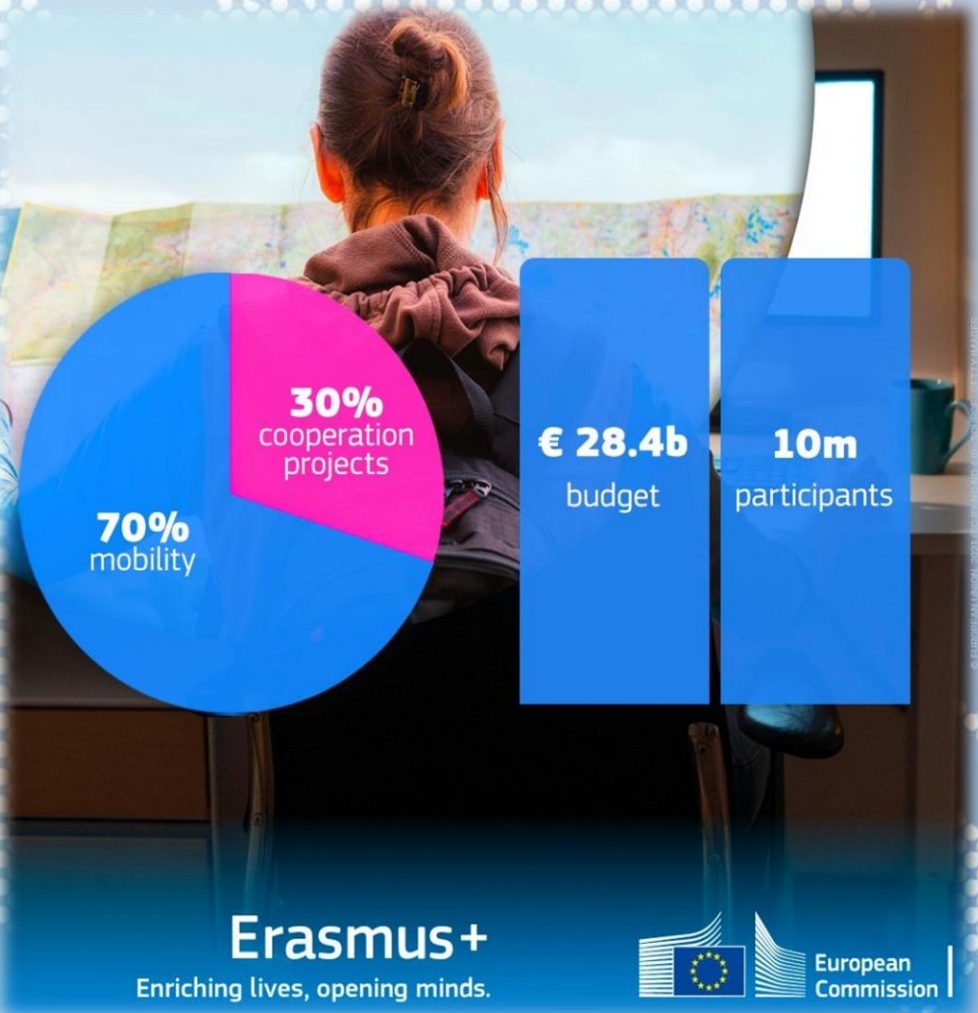

How it all started?

VET pilot mobility scheme 2018

- Decision of EC - The **European Commission's Strategy for the Western Balkans** significantly enhanced EU engagement to better support the Western Balkans' preparations on the European path:
- VET scheme is one of the actions foreseen for "*Supporting socio-economic development*" – a part of the global goal, one of the six flagship initiatives
- Allocating for VET scheme a budget of 2 million EUR to put in place the VET scheme between the Enlargement countries, on the one side, and the EU Member States, on the other side.
- ***Results of Montenegrin participation in VET mobility scheme – 5 mobility projects in total (within 2 Calls for proposals)***

Montenegro in VET mobility scheme - Call for proposals (EAC/S34/2018)

INTERVET (Internationalisation of VET systems in Western Balkans)

- Coordinator - Italian organisation *Uniser Societa Cooperativa Sociale Onlus* based in Forli
- 7 Member States (Belgium, the Netherlands, France, Malta, Spain, Slovenia and Poland) + 1 partner from each of the Western Balkan countries, making a total of 14 partners
- **Partner from Montenegro: Chamber of Economy**

The Call for proposals **EAC/S34/2018**

- To introduce the “culture of learning mobility” in the field of VET that Europe has been knowing since the launch of the Erasmus programme
- Increase the capacities of VET teachers and headmasters on learning mobility and planning managing process of mobility projects
- To prepare young people for the transition to the labour market and at the same time support the development of local economies

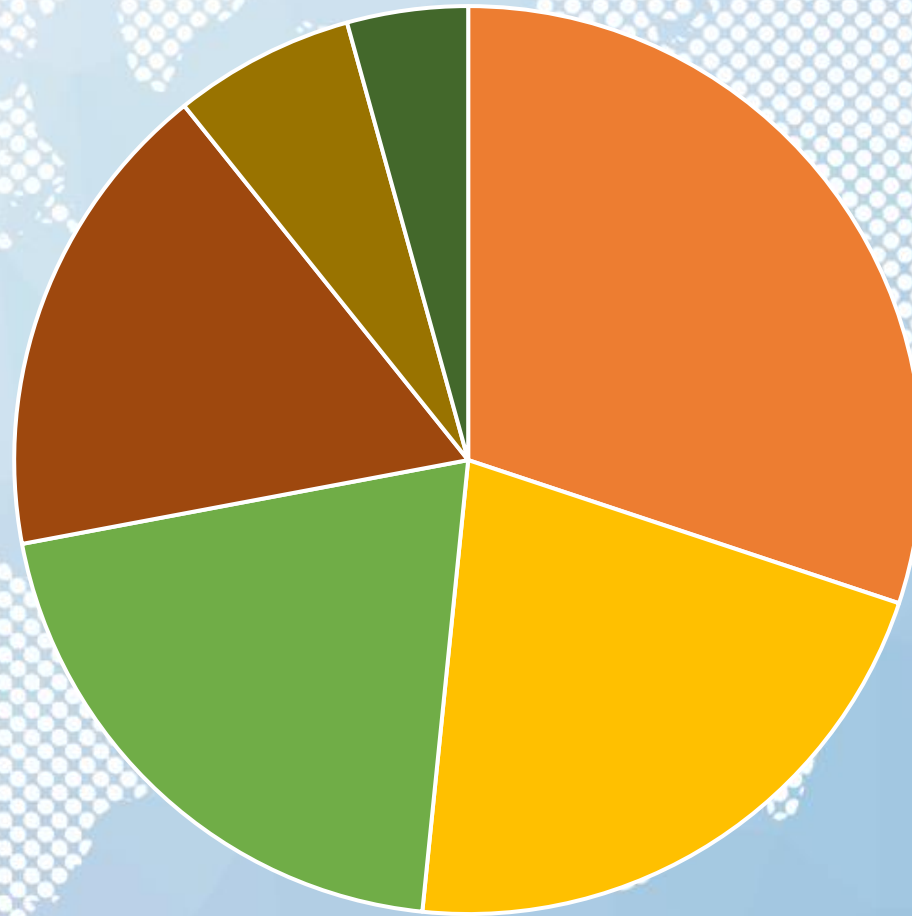

CB VET 2024 CALL - results

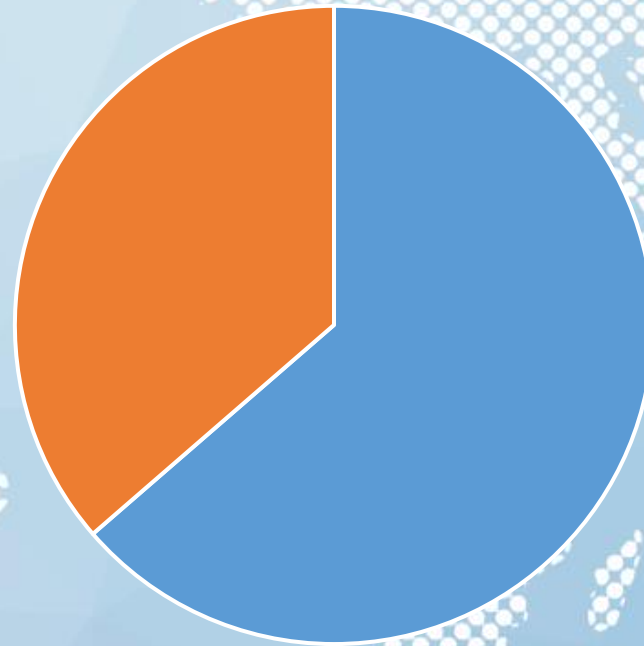
- **Total budget: 25.250.170 EUR**

The European Commission recommended **72** out of 280 eligible CB VET applications for funding (success rate – 26%). 78 third countries not associated to the programme are included in these 72 projects.

- **Western Balkans: 22 projects – Montenegro: 10 projects**
- Neighbourhood East: 9 projects
- South-Mediterranean countries: 11 projects
- Sub-Saharan Africa: 23 projects
- Latin America: 6 projects
- Caribbean: 1 project

Project Participation by Institution Type

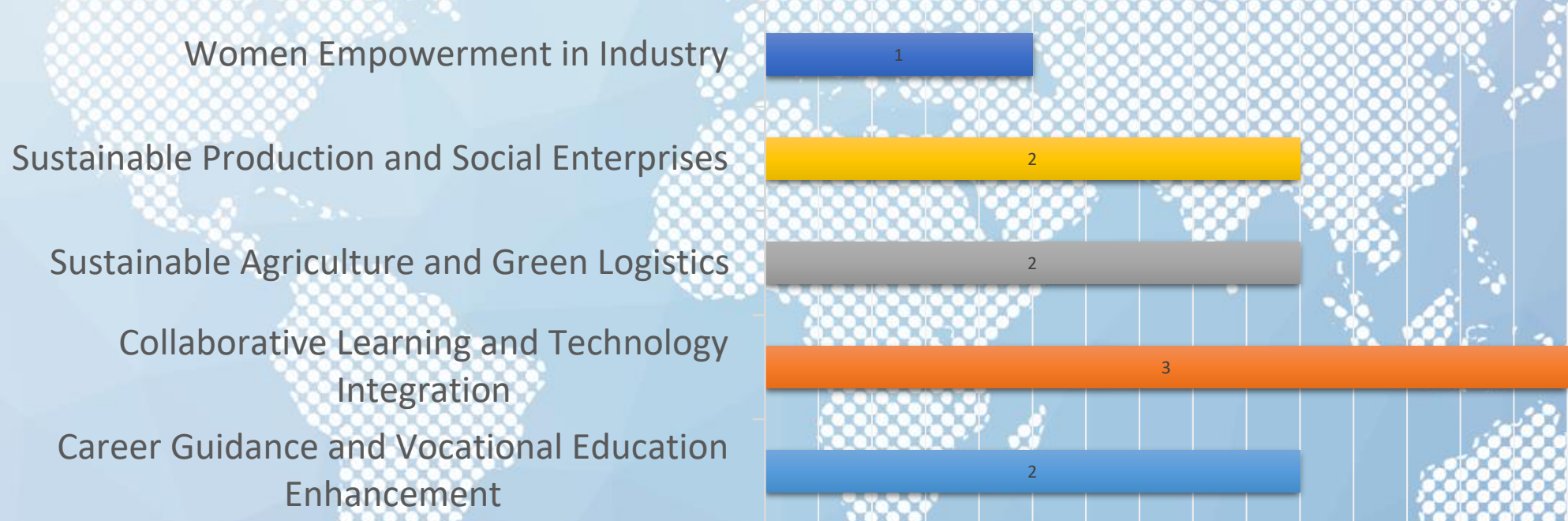

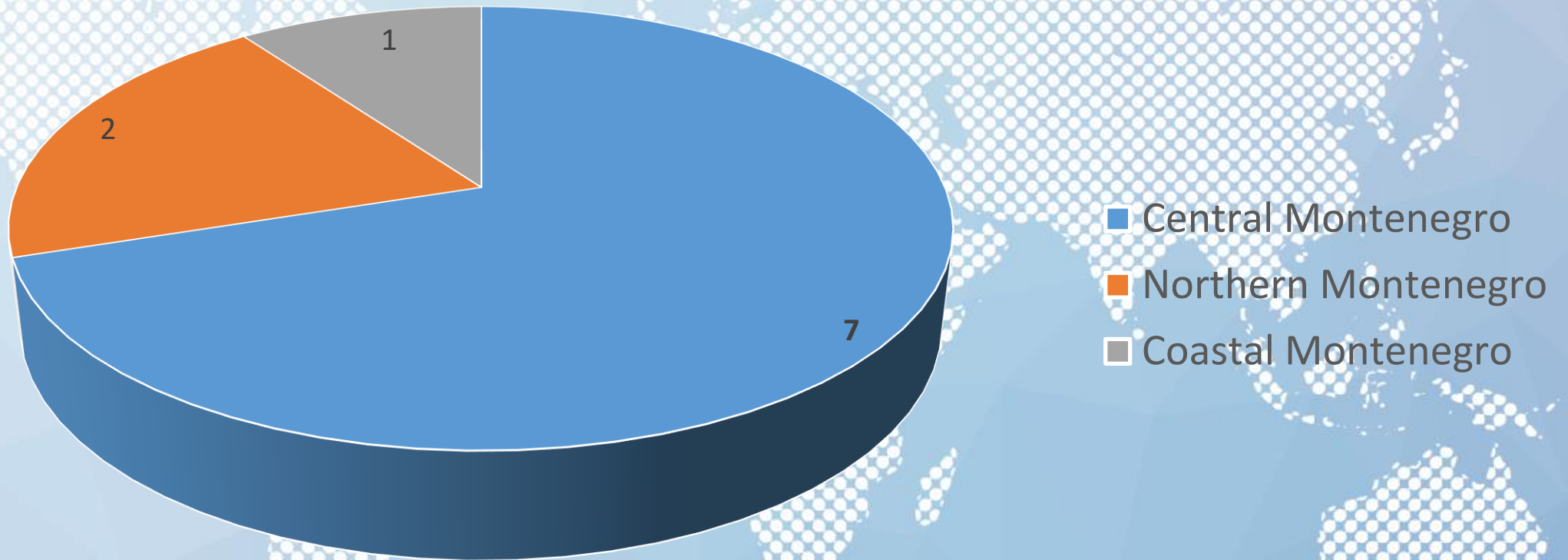
CB VET 2024 statistics – number of projects per institution
